In case the Chairperson is not available, then the Vice Chancellor shall appoint any other Director from the campus as the Chairperson for conduct of that particular grievance matter.


The term of the Chairperson and members of the Committee shall be of two years i.e., from 23<sup>rd</sup> February, 2026 to 22<sup>nd</sup> February, 2028.

The term of the special invitee shall be one-year i.e., from 23<sup>rd</sup> February, 2026 to 22<sup>nd</sup> February, 2027.

A member shall cease to be a member of the Campus Student Grievance Redressal Committee as soon as he/she ceases to belong to the category from which he/she became the member of the Committee.
