- In order to effectively serve the cause of serving/retired Defence Personnel in general and their children in particular, the Symbiosis Society, Pune registered under Societies Registration Act, 1860 (number MAH-679-PN) on 01.01.1971 and Bombay Public Trusts Act, 1950 (Number F/481/Pune) on 26th 1971 an Institute February has started Management studies (for defence personnel and their dependents). The Symbiosis Institute of Management Stidues (for Defence personnel and their dependents), hereinafter referred to as 'SIMS', was established on 08 February, 1993. APPOINTMENT OF THE POST OF DIRECTOR

- 12. It is agreed that the appointment of Director of SIMS shall be made by the Managing Committee of the Symbiosis society. The incumbent shall as far as possible be an Ex-serviceman with requisites qualifications and experience.
- offered by SIMS, other than the correspondence courses, shall be regulated in the manner as stated below.
- (a) Eighty percent vacancies for the full time two year/one year courses offered by SIMS, shall be allotted to the Defence personnel and their dependents only on the basis of their performance in the entrance examination and strictly on merit.
- (b) 10 percent vacancies shall be filled for the Defence Personnel and their dependents, by the

Management of SIMS, in consultation with Headquarters, Southern Command. This discretionary quota should cater for :-

- (i) Killed in action (war, Counter Insurgency, or war like operation).
- (ii) Disabled in action (war, Counter Insurgency or war like operations) with more than 50 percent disability.
- (iii)Next of kin of service personnel who have
 died while in service, death being
 attributable to military service.
- NOTE: Any unfilled vacancy of this 10 percent quota by the category at para 13(b) (1)

 (ii) and (iii) with also be allotted to defence personnel and their dependents only.
